RE: Received questions concerning the procedure for granting a concession for service for the object “Civil airport for public use Sofia”

DEAR SIR/MADAM,

In connection with received questions concerning the procedure for granting a concession for service for the object “Civil airport for public use Sofia”, we inform you as follows:

Question 1:

What is the estimated value of the concession and who are the consultants who have prepared the concession analyses?

Answer 1:

The estimated value of the concession is 2 675 876 000 BGN and in section XIII “Estimated value of concession and method for its calculation” of the Documentation for the participation in the opened procedure, published on the web site of the MTITC: <https://www.mtitc.government.bg/page.php?category=755&id=9140> is described its method of calculation.

Regarding the consultants who have prepared the concession analyses, on the web site of the MTITC in Bulgarian language: <https://www.mtitc.government.bg/page.php?category=693> you can find information about them and the contracts concluded with them.

Question 2:

What are the conditions for participation in the opened procedure for the concession of Sofia Airport? Can we get all the necessary information (English version documents) about the opened procedure, the documentation for participation in the opened procedure for granting this concession, the deadline, the documentation fee and any other relevant information?

Answer 2:

The Documentation for participation contains all the conditions for participation in the opened procedure for granting a concession for service for the object civil airport for public use Sofia. It is free and published in English on the web site of the MTITC: <https://www.mtitc.government.bg/page.php?category=755&id=9140>. The translation in English language has been prepared for the convenience of the participants in the procedure for granting a concession for service of civil airport for public use Sofia and it is not binding either for them or for the grantor of the concession. Binding for the participants as well as for the grantor of the concession are the documentation and its annexes, published in Bulgarian language. The deadline for submission of tenders is 20-th of October 2016.

Question 3:

We would like to ask you for a short meeting with introductory nature.

Answer 3:

Regarding your request for a meeting with introductory nature, concerning the procedure for granting a concession for civil airport for public use Sofia, we inform you that in accordance with the requirements of the Concession Act and the Regulation on the Implementation of the Concessions Act, it is not possible to be performed any actions connected with giving information about the granted concession, beyond certain cases determined by the Concession Act and the regulation for its implementation. The information about the opened procedure for granting a concession for service for the object “Civil airport for public use Sofia” – public state property is published and generally available on the web site of the Ministry of transport, information technology and communications, section “Concession of Sofia airport” (version in Bulgarian and English language).
